Establishing a Committee to Examine Cost Containment

A Joint Faculty Senate-Administration Committee to Examine Cost Containment Actions shall be established to document administrative cost containment activities within the University. The members of the committee shall be Marshall Blume (Wharton), Lee Peachy (SAS), Michael Aiken (Provost), Marna Whittington (Senior Vice President), and Steve Golding (Budget Director), ex-officio.

The members of the administration will share with the faculty members information about administrative cost containment activities that have occurred or are planned in the central administration as well as actions to reduce administrative costs within schools. The committee will also be a forum for suggestions about additional cost containment activities. It is hoped that the joint committee will be able to write a statement to be shared with the University community about its efforts.

Transportation Research Initiatives Fund: January 17

In order to enhance research in transportation at the University, a Transportation Research Initiatives Fund has been created, with support from The UPS Foundation. The purpose of the Fund is to provide small grants to faculty to develop new research initiatives in transportation and logistics. Particular emphasis is being given to research directed toward problems and issues of concern to the private sector, as a provider, user or beneficiary of transportation services. Thus, research on public policy and other public sector issues is not excluded, as these directly impact private transportation providers. Appropriate expenditures include: student assistance, particularly in preparing proposals or plans; staff assistance for similar purposes; conference planning; enhancements to computing equipment; computing costs; and travel for research purposes. It is contemplated that awards would be for a maximum of \$5,000, and be for a period of at most one year.

Proposals will be evaluated on the basis of their significance and potential for enhancing research in transportation at the University. Each proposal should be from two to five pages in length, and should specify the objectives, major tasks, and expected results (e.g., a proposal for external funding, plan of future work). A budget should be included, specifying major elements of expenditures, and other support for related work that the principal investigator has received or is seeking elsewhere. Upon completion of work undertaken with these funds, the awardee is expected to submit a statement of the accomplishments and copies of any materials produced. The deadline for proposals for work commencing during the spring or summer of 1992 is *January 17*, 1992.

Changes in Senior Posts

Friday the Trustees Executive Committee approved title changes for three senior administrators, in a domino effect of the decision of the University's chief planning officer, Dr. Robert Zemsky, to devote full time to the Institute for Research on Higher Education.

- Dr. Frederic Nahm, who has been vice president for development and university relations, becomes Senior Vice President for Planning and Development. He assumes Dr. Zemsky's planning duties, while the university relations operations are moved to:
- Secretary of the University Barbara Stevens, whose new title is Vice President and Secretary of the University.
- Dr. Marna Whittington, whose title has been senior vice president, is restyled Executive Vice President.

Call for Nominations: Deputy Provost

Nominations and applications for the position of Deputy Provost, currently held by Dr. Richard Clelland who is retiring this year, are now being solicited by the search committee. Candidates must be members of the University community.

The Deputy Provost is asked to deal with faculty issues of all kinds throughout the University and to provide the Provost with major advice and help on all important policy issues, including appointments and promotions, affirmative action, grievances, and personnel matters. He or she must be someone with whom the Provost, in the words of the faculty handbook, "can establish a close personal rapport."

Undergraduate Education Initiatives Fund

Proposals are once again being solicited for the Undergraduate Initiatives Fund established last year to encourage innovative initiatives in undergraduate education. All schools, departments, individual faculty, and the four undergraduate divisions are encouraged to participate in this competition by submitting proposals through their school dean.

Proposals to the Undergraduate Initiatives Fund for the 1992-93 Fiscal Year are due in the Provost's Office on Friday, February 14, 1992.

While the competition is open to proposals in all areas of undergraduate education, this year I would particularly welcome proposals which address one of the following themes selected in consultation with the Council of Undergraduate Deans:

- Undergraduate student recruitment and retention
- Strengthening of teaching including TA training
- Creating undergraduate research experiences
- Strengthening the freshman year
- Strengthening undergraduate advising
- Encouraging the instructional use of computing and the development of computer-intensive courses
- Furthering the internationalization of the undergraduate academic experience

Several comments that emerged during the course of the UIF Subcommittee's review of FY92 proposals may be helpful to you in formulating successful proposals for FY93:

- 1. Proposals should be *selected and integrated* by the Dean in the light of each School's own priorities.
- Proposals with major faculty involvement are especially encouraged.
- 3. The inclusion of an appropriate evaluation component and criteria in each proposal is desirable.4. The UIF is intended to promote *innovation and experimenta*-
- 4. The UIF is intended to promote *innovation and experimenta*tion. It is not intended to support existing or on-going activities of the undergraduate schools. In particular, normal curriculum development activities of individual faculty are not appropriate for UIF funding.
- 5. Each proposal should contain a clear indication of the School's commitment to institutionalizing a successful UIF-funded project without further UIF support in future years.
- Each proposal must make clear the intended use and the need for specific funds.
- 7. There may be areas in which joint efforts of two or more schools, or schools in partnership with other groups such as faculty in residence, may be appropriate for UIF funding, and such cooperative proposals are encouraged, particularly if they involve cross-school and interdisciplinary experiences.

In addition, please keep the following points in mind in developing submissions:

Undergraduate Initiatives Fund awards are not a form of subvention. Awards will be based on the merit of the proposals received, not on school size or "entitlement" to a predetermined percentage of funding.

UIF funds must be used for the purposes proposed. The standard University budget format should be used for all submissions, and a separate grant-like account in the University financial system will be established for each project funded.

All UIF awards are for one year. After a project's initial year of funding, a second year of funding may be requested for the implementation of a successful pilot or experimental program, where special circumstances make it impossible for the School to implement and institutionalize the project without a second year of UIF support.

Each project must have a designated project director. Except in unusual circumstances the project director should be a member of the standing faculty.

While the UIF is intended primarily to assist the four undergraduate Schools (Arts and Sciences, Engineering and Applied Science, Nursing, and Wharton), support is also available for undergraduate educational initiatives sponsored by the University's graduate and professional schools and their faculties. I encourage all deans, department chairs, and faculty members to consider ways in which they may contribute to the enhancement of the undergraduate academic experience with UIF support, particularly through programs involving partnerships with one or more of the undergraduate schools.

Please review the Guidelines carefully, and feel free to contact my office should you have any questions. A Subcommittee of the Academic Planning and Budget Committee will be appointed to review proposals and advise me on the selection of UIF recipients.

Guidelines and Organization of UIF Proposals

I. Purpose and Scope

- a. The purpose of the Undergraduate Initiatives Fund (UIF) is to encourage faculty, departments, and the four undergraduate schools to undertake innovative initiatives in undergraduate education.
- b. Funding may be sought from the UIF for either experimental/pilot projects or implementation projects designed to assist in institutionalizing innovations in undergraduate education.
- c. The Provost, in consultation with the Academic Planning and Budget Committee and the Provost's Council on Undergraduate Education, may choose to designate thematic priorities in undergraduate education for UIF proposals.
 - d. Funding may be awarded for:
 - Intra-school projects; or
 - Inter-school projects, involving two or more schools (or departments in different schools) in joint or coordinated ventures.
- e. All UIF awards shall be for one year. Second year funding will be considered upon presentation of evidence of a successful program and of a realistic plan for its institutionalization.

II. Proposal Solicitation, Development, and Submission Process

- a. Proposals will be solicited by the Provost from Deans, Undergraduate Deans, and undergraduate department chairs. The Provost shall also announce the UIF competition to all faculty in *Almanac*.
- b. Proposals may be initiated and developed, according to each school's applicable curricular and programmatic processes, by any University faculty member(s), department(s), or school(s). Proposals may also be initiated by the Council of Undergraduate Deans, and collective efforts of the Undergraduate Deans are especially encouraged. Final proposals shall be selected and forwarded to the Provost by the Undergraduate Dean(s) and Dean(s) of the participating school(s).
- c. Each individual project shall have a designated project director. Except in unusual circumstances, the project director shall be a member of the standing faculty.

III.Proposal Content

- a. Each individual project proposal shall contain:
 - a two-to-four page narrative describing the project's goals, activities, target population, and evaluation mechanism;
 - the name of the project director; and
 - a budget following the format provided by the UIF Subcommittee.
- b. Proposals involving implementation of programs or courses must provide evidence of the school(s)' commitment to the program's institutionalization.
- c. Each project proposal must contain appropriate mechanisms for evaluating the project's effectiveness.

IV. Proposal Selection Process

- a. The Provost shall annually appoint a subcommittee (the UIF Subcommittee) of the Academic Planning and Budget Committee (APBC), advisory to the Provost, consisting of three faculty members of APBC, one undergraduate student member of APBC, and two members of the Provost's staff.
- b. The UIF Subcommittee shall evaluate each proposal, with particular attention to its potential impact on the quality of undergraduate education, consulting with the relevant schools and project directors as necessary.
- c. The UIF Subcommittee shall recommend individual projects for funding ("Recommended"), consistent with the Provost's budgetary allocation. It shall also designate additional proposals it deems worthy of funding ("Fundable"), and those not recommended for funding ("Not Recommended")
- and those not recommended for funding ("Not Recommended").

 d. The Provost shall annually publish in *Almanac* the projects selected for UIF funding.

V. Project Evaluation/Reporting Requirements

- a. The director of each funded project shall prepare and submit to the appropriate Dean(s) and Undergraduate Dean(s) a two-page summary report of activities carried out under the award, including the results of the proposed evaluation. Each project director shall append to his or her annual report a brief annual budget and expenditure report from the University accounting system.
- b. Project reports must be forwarded by the appropriate Dean(s) to the Provost, for review by the UIF Subcommittee, no later than the September 15th following the end of the fiscal year for which the funds were awarded.
- c. Each year, the UIF Subcommittee shall review the project reports, and may request additional information from the project director or Dean(s).
- d. Prior to the solicitation of new proposals, the UIF Subcommittee shall present a written summary of its annual review to the Provost for discussion with the Academic Planning and Budget Committee and the Provost's Council on Undergraduate Education. The report shall be published in *Almanac*.

At the December 11 meeting of University Council, President Sheldon Hackney emphasized safety in his opening report, citing both a rash of incidents and a series of new steps taken by University Police—among them:

- Blue-light emergency phones in areas adjacent to the campus;
- Plainclothes police on 12-hour shifts;
- Increased foot patrols;
- Requests to SEPTA to increase its patrols;
- Meetings of Commissioner Kuprevich with security heads of nearby institutions and the 18th District;
- Extension of campus police patrols and walking escort to the temporary locations of University offices moved during renovations.

The President urged members of the University to make full use of escort and transportation services, and use on-campus autotellers.

In the Q & A period, Elizabeth Hunt of GAPSA asked that the campus bus and escort by van also be made available to those temporarily located on Market Street. Dr. Anthony Tomazinis asked if Penn's long-term approach was to become self-sustaining, with University budgets replacing city services—at costs he projected at up to \$25 million a year if individual school ex-penditures were included. Dr. Hackney said he believed costs to be under \$10 million, but offered to bring in more information. To the larger query, Dr. Hackney replied that Penn will probably take a middle course and that talks of the Commissioner with neighbors are designed to coordinate city and neighboring resources to that end.

Committees: Council voted down the bylaws change that would have increased faculty membership on the Bookstore Committee from six members to eight. Students charged that the action would dilute the student voice, and Under-

graduate Assembly chair Mitchell Winston read a statement both opposing the bookstore action and urging the overturn of a November action that increased the number of faculty on the Safety and Security Committee. In opposition, former Senate chair Dr. R.E. Davies said it was specified in Council's founding that on committees faculty would number as many as the students and others combined, plus one.

Also debated was the motion to add the Deputy Provost, ex officio, to the Personnel Benefits Committee, which had its first reading. Dr. Tomazinis suggested the addition of another high-ranking administrators would inhibit discussion, but Dr. Henry Teune said the Committee has highly technical work to do and needs all the help it can get.

As of December 16, eleven units of the University had exceeded their Penn's Way dollar goals, led by the Dental School at 179%. And the Committee has extended the campaign to January 6 "because of the holiday" break and because so many area residents still need our support," co-chairs Dean Ray Fonseca and Commissioner John Kuprevich said. All who have pledged by January 6 will find their names in the hat for the January 30 Grand Prize drawing—two round trip tickets anywhere in the continental U.S., donated by Rosenbluth Travel. Committee also forwards these words of the season from a donor/solicitor:

The proposal to eliminate the Committee on Undergraduate Admissions and Financial Aid was discussed in preparation for voting in January. After establishing the Provost's Council on Admissions in line with faculty advice based on statutes that specify the faculty role in admissions, Dr. Michael Aiken proposed the deletion of the Council Committee as duplication. Members of the current Committee, however, have voted unanimously to be continued.

Harassment: Council held a straw poll on an item presented for discussion, the Comprehensive Policy on Harassment (Almanac October 8). The majority voted against it after a series of faculty and student speakers questioned its purpose or the need for it given existing policies on sexual and racial harassment.
